FINANCIAL REPORT:

Mr. Muir discussed receipts and expenditures for December. For the month of December revenue is at \$343k for fresh potatoes, which is down \$43k compared to last year. Processed is at \$542k, down \$222k. Total for the month, we are at \$885k which is down \$266k compared to last year. YTD Fresh is up \$70k and Processed down \$200k, total YTD is down \$129k verses year ago which is due to less acres for processed than last year. Expenditures for the month are at \$1.5mil, verses budget of \$1.3mil, down \$200k. We are in line YTD where we need to be. YTD expenditures are at \$4.3mil verses \$5.2mil budgeted. Currently the reserve is at \$5.9 mil which is significantly higher than our target due to some programs on hold like the Big Idaho Potato Truck. Mr. Muir asked for a motion to approve the December financials if there were no further questions. There was discussion on shifting budget programs that are currently not running, to advertising funding and will be on agenda for March meeting.

<u>Legislation Update:</u> Mr. Muir reported briefly on presenting to the Senate Ag Committee and will be presenting to House Ag Committee on 1/28/21 on IPC Audit Report, Farmgate Revenue, IPC Mission Statement and the 2021 Legislative Update.

MOTION: Commissioner Nakamura made a motion to accept the December financials. Commissioner Van Orden seconded the motion. The motion carried unanimously.
